GRANT PROGRAM - GENERAL INFORMATION

AMOUNT OF GRANT

Grants range from \$500 to \$10,000

TERM OF GRANT

Grants are awarded for one year, unless the Foundation specifically approves a grant for a longer period.

RENEWAL OF GRANT

Renewal grant applications will be accepted during the regular application period and in the same form and will be considered and reviewed along with other current grant applications.

FORM OF GRANT

Grant applications should be in U.S. Dollars and in English. Grants are not limited to individuals or organizations within the United States of America. The Foundation will not discriminate on the basis of race, creed, color, age, sex, ancestry, religion, marital status, medical condition or physical disability.

DUE DATE & CALENDAR

January 31 Grant applications are due

May 31 Announcement of Grant Awards

Three months after Completion of Grant project, but no later than August 31:
Final report due (to address above) after completion of Grant.

ANNOUNCEMENT OF GRANTS

Announcement of grant awards will be made no later than May 31 following the January 31 application date, with funding to take beginning on June 1.

SELECTION PROCESS

A Selection Committee appointed by the Foundation Trustees will recommend grant awards to the Trustees of the Foundation who will make the final decision on grants. Grants will be awarded based on funds available and will be based on need and merit of the project or purpose at the sole discretion of the Foundation. The reason that an application was not selected for a grant will not be released.

RIGHTS OF THE FOUNDATION

The Foundation reserves the right for inspection of facilities involved in Grant monies at any time, the right to take and use photographs in newspapers or Alpha Gamma Delta publications and the right to obtain information from references in conjunction with the application process. The Foundation reserves the right to require interim reports on Grants at their sole discretion.

TERMINATION OF A GRANT

If a Grant recipient fails to comply with the terms and conditions of the award, or if any information on the Grant Application is deemed to be inaccurate, the Foundation may terminate the grant immediately and cease any future funding.
